4. Applicant qualifications

4.1. Applicants must graduate with a bachelor degree or study in the final year of a bachelor program.

4.2. Non-Thai applicants must possess a valid passport from the country of origin. The passport expiry date should be no less than 6 months from the last day of the application period. A visa to visit the Kingdom of Thailand must be obtained, following the regulations of the Immigration Bureau before the indicated interview date.

5. Application procedures and documents

Applicants must apply via online registration system at www.reg.kmitl.ac.th along with providing original or certified copies of supporting documents including:

5.1. A copy of an academic certificate or document confirming that the applicant satisfies the requirements in section 4.1.

5.2. A copy of Thai national ID card, or for non-Thai applicants, a copy of your passport with the expiry date being no less than 6 months from the last day of the application period.

6. Application selection

6.1 The selection of the accepted applicants for the interview is based on the individual's qualifications. The Faculty of Medicine, KMITL is an Equal Opportunity Institution. We select the applicants based solely on academic achievements and potential to become a graduate student regardless of race, sex, gender, socioeconomic status, and political view.

6.2 The qualified applicants are subjected to the interview examination. The consideration will include several factors to evaluate the applicant's eligibility for acceptance such as work experience, publications, topic of interest, personality and attitude of the applicant. The scores of applicants will be ranked and announced for the confirmation of the enrollment positions.

7. Admission confirmation and tuition fee payment

Admitted applicants are required to submit an online form to confirm his/her intent to enroll and pay the tuition fees for Semester 1/2025 in full. If the payment is not made on the due date, it will be considered a waiver. There will be no refunds under any circumstances (see details on the announcement of the eligible applicants for admission).

8. New student matriculation

New students must register into the KMITL system with an official transcript through www.reg.kmitl.ac.th/matriculation.
